RETURN PURSUANT TO ART. 13 OF THE EUROPEAN REGULATION 2016/679

ON THE PROTECTION OF INDIVIDUALS WITH REGARD TO THE PROCESSING OF THEIR PERSONAL DATA

Dear User, we wish to inform you that on April 27, 2016 the European Regulation 2016/679 was approved concerning the protection of individuals with regard to the processing of personal data, as well as the free circulation of such data and which repeals Directive 95/46 / EC. (general regulation on data protection).

This Regulation, which hereinafter, for the sake of brevity, we will indicate with the acronym GDPR (General Data Protection Regulation) entered into force on May 25, 2016 and is directly applicable in all states of the European Union from May 25, 2018.

Aware of the fact that its members are the beating heart of the association, AICS - Italian Culture and Sport Association – owner of the out-sport.eu website, has undertaken a process of protecting their personal data by adopting, in light of the provisions of the GDPR, adequate technical and organizational aimed at safeguarding their conservation and integrity.

Therefore, in compliance with the provisions of art. 13 of the GDPR, the following information is provided to the interested parties:

#### **Purpose of data processing**

Your data will be processed for the entire duration of the relationship and also subsequently, for the fulfillment of legal obligations and for administrative and commercial purposes.

#### **Legal basis for data processing**

Aics treats your anonymous navigation data for the sole purpose of monitoring the technical functioning and performance of the site, to understand how to improve services and make them evolve. These data are necessary to ensure the provision of the site.

#### **Methods of data processing**

The personal data acquired for the technical operation of the site are processed with automated tools for the time strictly necessary to achieve the purposes for which they were collected and as indicated above. Specific security measures are observed to prevent data loss, illicit or incorrect use and unauthorized access.

In carrying out these activities, AICS can avail itself of the help of external companies, consultants, consortia, software and service providers all appointed as Data Processors and operating, through identified and appointed personnel, within the scope of the intended purposes and in order to guarantee the highest possible data security.

The personal data provided by users who forward contact requests relating to the services offered by AICS and their eventual activation or request to receive information through the alert system are used for the sole purpose of performing the service or provision requested and are communicated to third parties only in the event that this is necessary for this purpose (shipping and forwarding services). Specifically, however, we refer to the text of the information present at the bottom of each form.

### **Mandatory / optional nature of providing data**

Apart from the above, the possibility remains for the user not to provide their personal data. Failure to provide, however, in some cases, can compromise access, use and provision of online services, as well as the quality of the expected service.

### **Types of data**

#### **Navigation data**

Log files: the computer systems and applications dedicated to the operation of the website out-sport.eu detect, during their normal operation, some data (the transmission of which is implicit in the use of Internet communication protocols) not associated with directly identifiable users. The collected data includes the IP addresses and domain names of the computers used by users who connect to the site, the addresses in the Uniform Resource Identifier (URI) notation of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters regarding the operating system and the IT environment used by the User. These data are processed, for the time strictly necessary, for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its regular functioning.

#### **Cookies**

No computer techniques are used on the website out-sport.eu for the direct acquisition of the user's personal identification data or user profiling systems. I c.d. Technical session cookies, once the connection to the site is terminated, they are not stored. Our computer systems use: cookies to transmit information of a personal nature, and no type of persistent cookies.

A "cookie" is a text file saved on the user's computer when he accesses a website with the aim of providing information every time the user returns to the same site. It is a sort of reminder of the visited internet page. With the cookie, the web server sends information to the user's browser (Internet Explorer, Mozilla Firefox, Google Chrome, etc.) stored on the latter's computer, and will be re-read and updated each time the user returns to the site. In this way, the website can automatically adapt to the user. During navigation, the user may also receive cookies from different sites ("third party" cookies) on his terminal, set directly by the managers of said websites and used for the purposes and in the manner defined by them.

Depending on their duration, they are divided into session cookies (i.e. those temporary and automatically deleted from the terminal at the end of the browsing session, by closing the

browser) and persistent cookies (i.e. those that remain stored on the terminal until their expiration or cancellation. by the user).

Based on the function and purpose of use, cookies can be divided into technical cookies and profiling cookies.

### **Technical cookies**

Some cookies are used to perform computer authentication, session monitoring and storage of specific information about users who access a web page. These so-called technical cookies are often useful to allow you to browse a website and use all its features. Technical cookies are those whose use does not require the user's consent.

The analytics cookies also belong to this category. These are cookies that collect information about the use that a user makes of a website and that allow to improve its functioning. For example, the analytics cookies show which pages are most frequently visited, allow you to check which are the recurring patterns of use of a website and help to understand any difficulties that the user encounters in use.

### **Profiling cookies**

Other cookies can instead be used to monitor and profile users while browsing, study their movements and habits of web consultation or consumption (what they buy, what they read, etc.), also for the purpose of sending advertising of targeted services and customized. In this case we speak of profiling cookies. The use of these cookies requires the prior acquisition of the user's free informed consent pursuant to art. 7 of EU Regulation 2016/679.

### **Third party cookies**

It may also happen that a web page contains cookies from other sites and contained in various elements hosted on the page itself, such as advertising banners, images, videos, maps or specific links to web pages of other domains that reside on servers other than that on which the requested page is located. In other words, these cookies are set directly by website managers or servers other than this website. In these cases we are talking about so-called third-party cookies, which are usually used for profiling purposes. The use of these cookies requires the prior acquisition of the user's free informed consent.

### **Types of cookies used by our site**

The main functions of the cookies installed on the out-sport.eu site are of a technical nature, they are used to constantly improve the Service, for authentication, for statistical purposes, such as counting visits to the site. The use of cookies is therefore strictly aimed at facilitating the functions of the server while browsing the Service.

The site also allows the sending of the following third-party cookies. These cookies are not tools owned by us, for more information, therefore, you can access the information and the third-party consent acquisition forms by clicking on the links shown.

To improve the website and understand which parts or elements are most appreciated by users, third-party cookies from Google Analytics are used as an anonymous and aggregate analysis tool. These cookies are not tools owned by us, for more information, therefore, you can consult the information provided by Google.

### **Cookie management**

The user can manage their cookie preferences through the features present in common browsers that allow you to delete / remove cookies (all or some) or to change the settings of the browser itself in order to block the sending of cookies or limit it to specific sites (compared to others).

Therefore, you can deny the use of cookies by following the disabling procedure provided by your browser. Below are the methods proposed by the main browsers: Microsoft Windows Explorer, Mozilla Firefox, Google Chrome, Apple Safari, Google Analytics by downloading a specific browser plug-in.

AICS has adopted every useful measure to mask the IPs of those who visit its site and does not allow the third party Google Inc. to cross-reference information with others it already has.

That said, please note that most browsers currently in use automatically accept cookies, but the User retains the right to configure their browser in such a way as to exclude, view before accepting and deleting cookies. However, it will always be possible to request the deactivation of cookies by changing the browser settings, but such deactivation may slow down or prevent access to some parts of the Site.

### **Data provided voluntarily by users / visitors**

If by connecting to this site you decide, where applicable, to send your personal data (for example: name, surname, email address) to access certain services, or, to make requests via email, AICS will process such data to respond to your request, or to provide you with the service requested by you in accordance with this information and the specific privacy information provided during the registration phase for the individual services. The data will be kept for the time necessary to provide the requested service and to manage any disputes. Your personal data will be disclosed to third parties only in the event that the communication is necessary to comply with the requests of the users themselves, as specified in the specific information of the individual services, or to simplify - at your request - the registration operations to sites / applications. of third parties. You will not be asked for health data and, in general, special categories of personal data referred to in Article 9 of the GDPR (biometric, genetic, criminal, etc.).

## **Obligation or right to provide data and consequences of any refusal**

Regarding the data that we are obliged to know, in order to fulfill the obligations established by laws, EU regulations and national legislation, or by provisions issued by Authorities legitimated by the law and by supervisory and control bodies, failure to provide them by you will make it impossible to establish or continue the relationship, to the extent that such data are necessary for the execution of the same. As for the data that we are not obliged to know, failure to obtain them will be evaluated by us from time to time, and will determine the resulting decisions related to the importance for us of the data requested but not provided by you.

## **Communication**

Your personal data may be communicated by us:  
to persons appointed within our structure to process data, and in particular to the employees of our administrative offices;

to subjects who can access the data by virtue of the provisions of the law, or community legislation, within the limits established by law;  
to subjects who need to access data for auxiliary purposes to the existing associative relationship, within the limits strictly necessary to carry out the auxiliary tasks entrusted to them;  
to consultants of AICS, within the limits necessary to carry out their assignment, subject to our letter of appointment which imposes the duty of confidentiality and security in the processing of data; to other external subjects in their capacity as organizers and partners in AICS institutional activities, related sporting events and any other event in which you request to participate through the out-sport.eu website. to Public Administrations and bodies for legal compliance;  
to Coni Servizi S.p.A. and Coninet S.p.A. for the respective obligations of competence.

## **Dissemination of data**

Your data will not be disseminated. Data transfer outside the EU Your data will not be transferred to countries outside the European Union.

## **Automated decision making**

With reference to the data you have provided, we inform you that there is no automated decision-making process, nor any profiling activity referred to in Article 22, paragraphs 1 and 4 of the G.D.P.R.
